Students are required to complete at least 128 credits (inclusive) for graduation, including 30 credits of General Education curriculum, (required language courses, core general education courses, and elective general education courses), 15 credits of the college core courses, 27 credits of the departmental core courses, and completion of at least one Professional Program in this department, as well as 15 credits of the Interdisciplinary Program, 15-16 credits of Interdepartmental

Specialization Program, or 9-10 credits of Interdepartmental Sub-Specialized Program (one of the three is required). Students who have obtained less than 128 credits are required to take "department professional electives" or "electives" of other majors, or other courses recognized by the department to make up for the credits required for graduation.

In addition to completing the total number of credits for graduation, students of the bachelor's degree are required to complete the Graduation Basic Competency Assessment, i.e., they should possess "four basic professional certificates in finance and economics" or "two advanced professional certificates in finance and economics" in order to be qualified for graduation, please refer to the "Essentials of Graduation Basic Competency Assessment for the Students of the Department of Finance and Economics, Asia University".

In addition, completion of the "Double Major" or "Minor" may also be included in the "Interdisciplinary Studies" graduation credits (the "Interdisciplinary Studies" include "Double Major", "Minor", "Interdisciplinary Program", "Interdepartmental Specialization Program", or "Sub-Specialization").
